


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(In support of Frank Harris as Representative  
of the Tohono O'Odham Nation)


1 WHEREAS, the Tohono O'Odham Legislative Council acknowledges the distinguished  
2 O'Odham men that have served in the United States Armed Forces; and  
3 WHEREAS, one of the many outstanding men that served in the United States 6th  
4 Marine Division was one Mr. Frank Harris of Choulic, Arizona of the  
5 Tohono O'Odham Nation; and  
6  
7 WHEREAS, Mr. Frank Harris is traveling to Okinawa on June 14, 1987 to represent  
8 the United States and the United States 6th Marine Division at a  
9 dedication of a memorial to the Japanese and Americans killed there;  
10 and  
11 WHEREAS, the Tohono O'Odham Legislative Council recognizes the ceremony as an  
12 important event for Mr. Frank Harris as well as for the Tohono O'Odham  
13 Nation.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does  
16 hereby designate Mr. Frank Harris as an official representative of the  
17 Tohono O'Odham Nation.  
18  
19 BE IT FURTHER RESOLVED that Mr. Frank Harris is representing all the Native  
20 American Indians.

21 The foregoing resolution was passed by the Tohono O'odham Council on the 8th  
22 day of June, 1987, at a meeting at which a quorum was present with a vote of  
23 1577.0 for; -0- against; 63.0 not voting; and 03 absent, pursuant to the powers  
24 vested in the Council by Section 1 (b) of Article VI of the Constitution of the  
25 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
26 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
27 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
28 1934 (48 Stat. 984).



5 either approve or disapprove it within 48 hours of submittal.


