1 WHEREAS, at a special meeting of the Schuk Toak District Council, held on April  
2 24, 1987 at which a quorum of the District Council was present; and


3 WHEREAS, the State of Arizona, by and through its Department of Transportation,  
4 wishes to obtain the necessary rights of way on the Tohono O'Odham  
5 Reservation in conjunction with an improvement project on State Route  
6 386 which is the Kitt Peak Observatory Road.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council, due  
8 to the urgency to build and repair such roads for suitable crossings,  
9 supports and approves granting of right-of-way for:

17 powers vested in the Council by Section 1(i)(1) of Article VI of the Constitu-  
18 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
19 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
20 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
21 of June 18, 1934 (48 Stat. 984).
