

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Referring purchase of Jordan land to Budget & Finance,
Natural Resources & Commerce Committee)

RES. NO. 221-87

1 WHEREAS, the Tohono O'Odham Legislative Council has chosen not to entertain
2 consideration of the negotiation purchase of the "Jordan" land at Gila
3 Bend for the San Lucy District through a separate loan guarantee, on
4 the June agenda of the Legislative Council; and

5
6 WHEREAS, said parcel of land (234.4 acres) is absolutely essential to the land
7 acquisition and further development of the San Lucy District under
8 P. L. 99-503 and will be lost in June due to prior sale if Legis-
9 lative Council action is not forthcoming with negotiations (and
10 appraisal) now amicably completed.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council
12 hereby considers the purchase of the "Jordan" land without considering
13 the matter of the loan guarantee at this time so that this land
14 purchase so essential to the San Lucy District may not be permanently
15 lost, thus permitting other means of financing to be developed for the
16 purchase this summer.

18 BE IT FURTHER RESOLVED that the purchase of the "Jordan" land be referred
19 immediately to the Budget & Finance, Natural Resources and Commerce
20 Committee for review and appropriate action.

22 The foregoing resolution was passed by the Tohono O'odham Council on the 8th
23 day of June, 1987, at a meeting at which a quorum was present with a vote of
24 1331.5 for; 308.5 against; -0- not voting; and 03 absent, pursuant to the
25 powers vested in the Council by Section 1 (b) (i) (3) of Article VI of the
26 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
