	Bend for the San Lucy District through a separate loan guarantee, on					
	the June agenda of the Legislative Council; and					

- WHEREAS, said parcel of land (234.4 acres) is absolutely essential to the land acquisition and further development of the San Lucy District under P. L. 99-503 and will be lost in June due to prior sale if Legislative Council action is not forthcoming with negotiations (and appraisal) now amicably completed.
- NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby considers the purchase of the "Jordan" land without considering the matter of the loan guarantee at this time so that this land purchase so essential to the San Lucy District may not be permanently lost, thus permitting other means of financing to be developed for the purchase this summer.
- BE IT FURTHER RESOLVED that the purchase of the "Jordan" land be referred immediately to the Budget & Finance, Natural Resources and Commerce Committee for review and appropriate action.

The foregoing resolution was passed by the Tohono O'odham Council on the 8th day of June, 1987, at a meeting at which a quorum was present with a vote of 1331.5 for; 308.5 against; -0- not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1 (b) (i) (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
