4 Frazier which is in accordance with the Enrollment Ordinance; and


5 WHEREAS, the Enrollment Committee informed the Council that the Notice of

7 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the
8 recommendation to reject membership to Leona L. Frazier be tabled.


9 BE IT FURTHER RESOLVED by the Legislative Council that the Enrollment Committee
10 proceed with their investigation to try and determine Leona L.
11 Frazier's membership through documentation.

14 day of July, 1987, at a meeting at which a quorum was present with a vote of
15 1331.0 for; 128.5 against; 180.0 not voting; and 02 absent, pursuant to the
16 powers vested in the Council by Section 1 (a) of Article VI of the Constitu-
17 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
18 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
20 of June 18, 1934 (48 Stat. 984).
