WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the Enrollment Committee and approves thereof.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that, subject to the approval of the Secretary of the Interior, the names of the following persons be added to the official census rolls of the Sells, Gila Bend or San Xavier Reservation, to wit:

1594-SO-87 JUAN, Morlegee

BE IT FURTHER RESOLVED that the required approval be secured from the Secretary of the Interior before their names be formally added to such rolls.

The foregoing resolution was passed by the Tohono O'odham Council on the $\underline{1st.}$ day of \underline{July} , $\underline{1987}$, at a meeting at which a quorum was present with a vote of 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1(a) of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
