WHEREAS, Section 1 (a) of Article II of the Constitution of the Tohono O'odham Nation provides that the Tohono O'odham Council can make additions and changes to the official census rolls of the Sells and Gila Bend Reservations dated January 1, 1937, and of the San Xavier Reservation dated January 1, 1940, subject to the approval of the Secretary of the Interior; and

WHEREAS, the Enrollment Committee has determined that the following named persons were members of the Tohono O'odham Nation on the date of the respective census rolls but that their names had been inadvertently omitted therefrom, and had recommended that their names be added to the rolls; and

WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the Enrollment Committee and approves thereof.


NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that, subject to the approval of the Secretary of the Interior, the names of the following persons be added to the official census rolls of the Sells, Gila Bend or San Xavier Reservation, to wit:

1594-S0-87 JUAN, Morlegee

BE IT FURTHER RESOLVED that the required approval be secured from the Secretary of the Interior before their names be formally added to such rolls.

The foregoing resolution was passed by the Tohono O'odham Council on the 1st. day of July, 1987, at a meeting at which a quorum was present with a vote of 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1(a) of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
