(Tohono O'Odham Council Representative-Sells District)

1 WHEREAS, on the 8th day of April, 1986, the Tohono O'Odham Council passed
2 Resolution No. 228-86 (Affecting terms of Office of elected public
3 officers, Article X, Section (3) of the Tohono O'Odham Constitution;
4 and

5 WHEREAS, Dennis E. Jose did submit his resignation to the Tohono O'Odham
6 Council by memorandum dated the 5th of May 1986; and

7 WHEREAS, on the 15th day of November, 1986, the Sells District Council did
8 approve by Resolution No. 6086, appointing Sylvester J. Listo, Sr., to
9 be the alternate representative to the Tohono O'Odham Council by
10 Article XII, Section (c) of the Tohono O'Odham Constitution.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
13 it does hereby approve Resolution No. 6086 of the Sells District
14 Council.

16 The foregoing resolution was passed by the Tohono O'odham Council on the 7th
17 day of January, 1987, at a meeting at which a quorum was present with a vote of
18 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers
19 vested in the Council by Section 1 (g) of Article VI of the Constitution of the
20 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
21 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
22 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
23 1934 (48 Stat. 984).
