8 cussion of the Membership of the Water Resources Committee.


9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council

15 day of July, 1987, at a meeting at which a quorum was present with a vote of  
16 1,364.0 for; 276 against; -0- not voting; and 01 absent, pursuant to the powers  
17 vested in the Council by Section 1 (a) of Article VI of the Constitution of the  
18 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
19 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
20 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
21 1934 (48 Stat. 984).
