(Approval of Baboquivari District Revenue Sharing Budget FY 1987)

1 WHEREAS, the Baboquivari District Council had approved and adopted the attached
2 Revenue Sharing Budget for FY-1987 for the Baboquivari District; and,

3 WHEREAS, the Baboquivari District Revenue Sharing has sufficient funds to cover
4 such budget; and,

5 WHEREAS, the Tohono O'odham Nation's Legislative Council has reviewed such
6 budget and approves of same.

7 NOW, THEREFORE, BE IT RESOLVED, by the Tohono O'odham Nation's Legislative
8 Council that it does hereby approve the attached FY-1987 Revenue
9 Sharing Budget of the Baboquivari District and does hereby authorize
10 expenditures from the District's Revenue Sharing accounts in
11 accordance therewith.

13 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
14 day of July, 1987, at a meeting at which a quorum was present with a vote of
15 1,640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the
16 powers vested in the Council by Section 1 (d)(3) of Article VI of the Consti-
17 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
18 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
20 of June 18, 1934 (48 Stat. 984).
