

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the Establishment of an Economic Development Fund;
Transfer of Funds by Gu Vo District)

RES. NO. 231-87

1 WHEREAS, the Tohono O'odham Legislative Council did by Resolution No. 516-87
2 allocate \$100,000.00 to each District from the mining royalties for
3 the sole purpose of economic development, and;

4 WHEREAS, the Gu Vo District Council has determined that in order to adequately
5 plan the usage of such funds for maximum benefit of the district,
6 sufficient time must be devoted to obtaining input from the communi-
7 ties and residents, and;

8 WHEREAS, it would be in the best interests of the District and for the purposes
9 for which said funds were allocated, to place the funds into an
10 interest bearing account.


11 NOW, THEREFORE, BE IT RESOLVED BY THE TOHONO O'ODHAM LEGISLATIVE COUNCIL that
12 it does hereby authorize the Gu Vo District to establish an Economic
13 Development Fund, utilizing the \$100,000.00 allocated by Resolution
14 No. 516-87 of the Tohono O'odham Legislative Council.

15 BE IT FURTHER RESOLVED, said funds shall be deposited into an interest bearing
16 account; interest accumulated, shall be made available for use by the
17 Gu Vo District to develop an Economic Development Plan for the
18 District.

19 BE IT FURTHER RESOLVED, that the Gu Vo District Council is hereby authorized
20 to transfer such funds from the All Districts IIM account to an
21 appropriate interest bearing account to be established for the benefit
22 of the Gu Vo District.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
24 day of July, 1987, at a meeting at which a quorum was present with a vote of
25 1,640 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers
26 vested in the Council by Section 1 (d) (3) of Article VI of the Constitution of
27 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
28 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
29 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
30 1934 (48 Stat. 984).
