11 interest bearing account. 12 NOW, THEREFORE, BE IT RESOLVED BY THE TOHONO O'ODHAM LEGISLATIVE COUNCIL that 13 it does hereby authorize the Gu Vo District to establish an Economic 14 Development Fund, utilizing the \$100,000.00 allocated by Resolution 15 No. 516-87 of the Tohono O'odham Legislative Council. 16 BE IT FURTHER RESOLVED, said funds shall be deposited into an interest bearing 17 18 account; interest accumulated, shall be made available for use by the 19 Gu Vo District to develop an Economic Development Plan for the 20 District. 21 BE IT FURTHER RESOLVED, that the Gu Vo District Council is hereby authorized 22 to transfer such funds from the All Districts IIM account to an 23 appropriate interest bearing account to be established for the benefit 24 of the Gu Vo District. 25

26 The foregoing resolution was passed by the Tohono O'odham Council on the 6th day of July, 1987, at a meeting at which a quorum was present with a vote of 27 1,640 for; -O- against; -O- not voting; and O1 absent, pursuant to the powers vested in the Council by Section 1 (d) (3) of Article VI of the Constitution of 28 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs 29 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 30
