

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointment of Lester Ormsby and Reappointment of Lyle L. Donovan  
on the PTUA Board)

RES. NO. 232-87

1 WHEREAS, the Plan of Operation of the Papago Tribal Utility Authority provides  
2 that the Tohono O'odham Council shall appoint the Directors of PTUA  
3 upon expiration of said term; and

4 WHEREAS, the term of Lyle L. Donovan and John T. McGue expires on June 30,  
5 1987; and

6 WHEREAS, John T. McGue, due to extended health condition desires not to be re-  
7 appointed, has created a vacancy on the PTUA Board; and

8 WHEREAS, the PTUA Board at its March meeting by unanimous vote recommends  
9 Lester Ormsby to fill the vacancy; and

10 WHEREAS, the Plan of Operation requires that four (4) members must have not  
11 less than ten years experience in business management; and

12 WHEREAS, Mr. Lyle L. Donovan and Mr. Lester Ormsby both meet the requirements  
13 as set forth in the Plan of Operation; and

14 WHEREAS, the PTUA Board of Directors recommends the appointment of Mr. Donovan  
15 and Mr. Ormsby for three year terms to expire on June 30, 1990.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that Mr. Donovan  
17 and Mr. Ormsby be appointed to the PTUA Board of Directors for a  
18 three (3) year term to expire on June 30, 1990.

19 The foregoing resolution was passed by the Tohono O'odham Council on the 6th  
20 day of July, 1987, at a meeting at which a quorum was present with a vote of  
21 1,523.0 for; 58.5 against; 58.5 not voting; and 01 absent, pursuant to the  
22 powers vested in the Council by Section 1 (b) of Article VI of the Constitu-  
23 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
24 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
26 of June 18, 1934 (48 Stat. 984).
