

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Skill Center)

RES. NO. 233-87

1 WHEREAS, the U.S. Department of Education, Office of Vocational and Adult
2 Education has invited applications for grants under the program for
3 Indian Tribes and Indian Organizations, CFDA number 84,10.a; and

4 WHEREAS, the purpose for inviting applications is to provide Federal support
5 to Indian Tribes to plan, conduct and administer projects or portions
6 of projects that are authorized by and consistent with Carl D. Perkins
7 Vocation Education Act (P.L. 98-524, 20 U.S.C. 2301 et. seg.); and

8 WHEREAS, the Tohono O'Odham Nation has successfully established and operated
9 the Tohono O'Odham Skill Center to provide vocational training to
10 Native Americans; and

12 WHEREAS, the Tohono O'Odham Nation has proposed a Grant application which will
13 provide funding for vocational training for Native Americans.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
15 approve the submission of the application to the U.S. Department of
16 Education, Office of Vocational and Adult Education for a Grant under
17 the Program for Indian Tribes and Indian Organizations to provide a
18 Vocational Indian Education training program through the Tohono
19 O'Odham Skill Center.

21 BE IT FURTHER RESOLVED that the duration of this Grant will commence on October
22 01, 1987 through September 30, 1988, unless extended by mutual agree-
23 ment of both parties.

24 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman or Treasurer of the
25 Tohono O'Odham Nation are hereby authorized to negotiate and execute
26 this Grant and amendments thereto for the duration of the Grant,
27 provided however that any amendments affecting the funding or funding
28 levels of the grant shall be submitted for further prior approval by
29 this Council.

1 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
2 day of July, 1987, at a meeting at which a quorum was present with a vote of
3 1597.5 for; -0- against; 42.5 not voting; and 01 absent, pursuant to the powers
4 vested in the Council by Section 1 (f) of Article VI of the Constitution of
5 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
6 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
7 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
8 1934 (48 Stat. 984).
