

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Sif Oidak District Budget FY 1988)

RES. NO. 234-87

1 WHEREAS, the Sif Oidak District Council has considered and reviewed its pro-  
2 posed activities for FY '88 and prepared a budget to cover anticipated  
3 cost and expenses; and

4 WHEREAS, the Sif Oidak District Council did by Resolution No. 11-87 approve the  
5 proposed budget for FY '88 in the amount of \$143,510.48, said budget  
6 period to begin on August 01, 1987 and end on July 31, 1988; and

7 WHEREAS, the Sif Oidak District maintains an account at the First Interstate  
8 Bank, Casa Grande and has authorized the following officers of the  
9 Council to have authority to sign checks on the account, the Chairman,  
10 Vice-Chairman, and Secretary; and

12 WHEREAS, the Sif Oidak District Council has sufficient funds in its IIM Account  
13 to cover the proposed budget.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that  
15 it does hereby approve the attached FY '88 Budget of the Sif Oidak  
16 District and authorizes expenditures in accordance therewith.

18 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that  
19 it does hereby authorize the Sif Oidak District to maintain a separate  
20 District Account with the First Interstate Bank of Arizona, Casa  
21 Grande, Arizona, which shall provide that any of the following  
22 officers of the District Council, the Chairman, ViceChairman, and  
23 Secretary be the signers.

25 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council does hereby  
26 give authority to the Sif Oidak District to transfer funds on deposit  
27 in the District's IIM Account into an account with the First Inter-  
28 state Bank of Arizona in Casa Grande, an amount not to exceed one half  
29 of the total District budget, and remainder to be transferred when  
30 needed to meet the District's budgeted expenses.

1 The foregoing resolution was passed by the Tohono O'odham Council on the 6th  
2 day of July, 1987, at a meeting at which a quorum was present with a vote of  
3 1,640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers  
4 vested in the Council by Section 1 (d) (3) of Article VI of the Constitution of  
5 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
6 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
7 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
8 1934 (48 Stat. 984).
