22	officers of the District Council, the Chairman, ViceChairman, and
23	Secretary be the signers.
24	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council does hereby
25	give authority to the Sif Oidak District to transfer funds on deposit
26	in the District's IIM Account into an account with the First Inter-
27	state Bank of Arizona in Casa Grande, an amount not to exceed one hal-

29	of the total District budget, and remainder to be transferred when
30	needed to meet the District's budgeted expenses.
