## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Waiving Legislative Rules to Allow Another Position on the Water Resources Committee)

DEFEATED

RES. NO. 236-87

WHEREAS, the Tohono O'odham Legislative Council was informed by the Sif Oidak District Legislative Council Members that they want representation on 3 the Water Resources Committee; and 5 WHEREAS, the Tohono O'odham Legislative Council were given copies of a letter dated June 11, 1987 written to the Nation's Chairman, Mr. Enos J. Francisco, Jr., regarding Legislative Water Resource Committee 8 Appointment Resolution No. 217-87; and

WHEREAS, the Sif Oidak Legislative Council Representatives did inform the Tohono O'odham Legislative Council of the pending legislation going before Congress in which they want to see its passage.

NOW. THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council consider waiving the number of positions in order to increase the membership of the Water Resources Committee.

AND BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council consider the appointment of a representative from the Sif Oidak District.

The foregoing resolution was passed by the Tohono O'odham Council on the 6th day of July, 1987, at a meeting at which a quorum was present with a vote of  $\underline{253.5}$  for;  $\underline{1,134.5}$  against;  $\underline{252.0}$  not voting; and  $\underline{-0}$  absent, pursuant to the powers vested in the Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
