(Tabling of Roads issue)

1 WHEREAS, the Legislative Council agenda for the January 8, 1987 meeting  
2 included the subject of Roads; and

3 WHEREAS, the Natural Resources Committee informed the Council that they had not  
4 reviewed the Roads item to offer any recommendations; and


5 WHEREAS, the Natural Resources Committee is the appropriate committee to review  
6 and discuss the subject of Roads before any action is made by the

8 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the Roads item  
9 on the agenda be tabled until the Natural Resources Committee has been  
10 given the opportunity to discuss and review the Roads.


11 BE IT FURTHER RESOLVED that upon completion of the Natural Resources Committee  
12 review that it will come back to Council with their recommendations  
13 and Council action.

15 The foregoing resolution was passed by the Tohono O'odham Council on the 8th  
16 day of January, 1987, at a meeting at which a quorum was present with a vote of  
17 1471.0 for; -0- against; -0- not voting; and 169.0 absent, pursuant to the  
18 powers vested in the Council by Section 1(a)(b) of Article VI of the Constitu-  
19 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
20 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
22 of June 18, 1934 (48 Stat. 984).
