19	order to improve access to, integration of, and quality of health care
20	services through an outreach program to adolescents, young adults, and

22	BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and Treasurer of the
23	Tohono O'odham Nation are hereby authorized to negotiate and execute
24	this contract and amendments thereto for the duration of the contract,
25	provided however, that any amendments affecting the funding or funding
26	levels of this contract shall be submitted for further prior approval
27	by this Council.
