

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Application for Health Promotion/Disease Prevention
Demonstration Grant)

RES. NO. 247-87

1 WHEREAS, the Tohono O'odham Legislative Council recognizes health, social, and
2 economic impact of chronic disease and health problems on the O'odham
3 community; and
4 WHEREAS, the Tohono O'odham Legislative Council is desirous to protect and
5 ensure the access to early disease prevention measures to ensure the
6 productive lives of adolescents and young adults and the proper care
7 of the elderly; and
8 WHEREAS, Dr. Rhoades, Director of the Indian Health Service has made available
9 \$350,000 to be divided among five or six community based demonstration
10 projects on Health Promotion/Disease Prevention on a one-time, short-
11 term basis; and
12 WHEREAS, it is the intent of the Tohono O'odham Legislative Council to better
13 integrate and coordinate existing health care resources for
14 adolescents, young adults and the elderly not now reached.

16 NOW, THEREFORE, BE IT RESOLVED by the Tono O'odham Legislative Council to apply
17 for a Health Promotion/Disease Prevention Demonstration Grant, in
18 order to improve access to, integration of, and quality of health care
19 services through an outreach program to adolescents, young adults, and
20 the elderly.

22 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and Treasurer of the
23 Tohono O'odham Nation are hereby authorized to negotiate and execute
24 this contract and amendments thereto for the duration of the contract,
25 provided however, that any amendments affecting the funding or funding
26 levels of this contract shall be submitted for further prior approval
27 by this Council.

1 The foregoing resolution was passed by the Tohono O'odham Council on the 9th
2 day of July, 1987, at a meeting at which a quorum was present with a vote of
3 1,539.0 for; -0- against; 101.0 not voting; and -0- absent, pursuant to the
4 powers vested in the Council by Section 1 (d) of Article VI of the Constitu-
5 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
6 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
7 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
8 of June 18, 1934 (48 Stat. 984).
