

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Schuk Toak Loan Application Negotiated Contract Amount
to Franzoy and Corey)

RES. NO. 251-87

1 WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 429-86
2 approved the Nation's Executive Branch to contract with Franzoy and
3 Corey for Small Reclamation Loan Application for the Schuk Toak
4 District; and

6 WHEREAS, the Tohono O'odham Legislative Council by the same resolution directed
7 that the negotiated amount be reviewed by the Legislative Council
8 prior to the contract between the Nation and Franzoy be executed; and

9 WHEREAS, the Tohono O'odham Legislative Council has reviewed and approved the
10 negotiated contract amount.


11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
12 hereby approve a contract amount to Franzoy and Corey Engineer and
13 Architects of \$80,000.00 to complete a Small Reclamation Loan
14 Application for the Schuk Toak District.

16 BE IT FURTHER RESOLVED that the authorized contract amount of \$80,000.00 will
17 be paid from the Water Settlement Trust Fund.

18 BE IT FURTHER RESOLVED that the Chairman or the Vice-Chairman of the Tohono
19 O'odham Nation are hereby authorized to negotiate and execute this
20 Contract or any amendments thereto for the duration of the Contract,
21 provided however, that any amendments affecting the funding or funding
22 levels of this Contract shall be submitted for further prior approval
23 by this Council.

25 The foregoing resolution was passed by the Tohono O'odham Council on the 17th
26 day of July, 1987, at a meeting at which a quorum was present with a vote of
27 1,480.5 for; 58.5 against; 101.0 not voting; and 0 absent, pursuant to the
28 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-
29 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
