(Approval of draft Environmental Assessment)

1 WHEREAS, the Tohono O'Odham Nation convened in a meeting on July 17, 1987 to
2 hear comments on the draft Schuk Toak Environmental Assessment; and

3 WHEREAS, the Council recognized the need to complete the environmental
4 documents and the planning activities required for by the Settlement
5 Act.


6 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Nation that the Schuk Toak
7 Environmental assessment prepared by Franzoy & Corey Engineers and
8 Architects and revised in accordance with the comments provided by the
9 Nation which are appended to the report, is hereby accepted as the
10 draft Environmental Assessment for submittal to the United States of
11 Reclamation.

12 The foregoing resolution was passed by the Tohono O'odham Council on the 17th
13 day of July, 1987, at a meeting at which a quorum was present with a vote of
14 1,360.0 for; 221.5 against; 58.5 not voting; and -0- absent, pursuant to the
15 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-
16 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
17 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
19 of June 18, 1934 (48 Stat. 984).
