WHEREAS, the Legislative Council on January 8, 1987 approved the Solid Waste 2 Program budget beginning January 1, 1987 - December 31, 1987; and 3 WHEREAS, the question of how the Program is funded since the original grant 4 ended September 30, 1986; and 5 WHEREAS, members of the Legislative Council sees the continuance of the Solid 6 Waste Program beyond the authorized period as a violation of the 7 8 resolution. 9 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the Nation's 10 Chairman provide in writing by Monday (January 12, 1987) to the 11 Legislative Council how he plans to cover expenditure of funds under 12 the Solid Waste Program. 13 BE IT FURTHER RESOLVED that failure to provide the information would constitute 14 a gross neglect of duty and that proceedings for his removal be 15 16 initiated. 17 The foregoing resolution was defeated by the Tohono O'odham Council on the 8th day of January, 1987, at a meeting at which a quorum was present with a vote of 18 476.0 for; 545.5 against; 449.5 not voting; and 169.0 absent, pursuant to the powers vested in the Council by Section 1 of Article XIII of the Constitution 19 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian 20 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of 21 June 18, 1934 (48 Stat. 984). 22 TOHONO O'ODHAM LEGISLATIVE COUNCIL 23 24 Harriet Toro, Legislative Chairperson 23" day of January, 1981. 25 26
