

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY '88 Alcoholism Contract Proposal Amendment)

RES. NO. 260-87

1 WHEREAS, the Tohono O'Odham Legislative Council did pass Resolution No's. 153
2 and 154-87 to authorize and request the Public Health, Indian Health
3 Service to contract with the Tohono O'Odham Nation under P. L. 93-638
4 regulations and procedures for provisions of services titled:
5 Psychological Services and Alcoholism Program; and


6 WHEREAS, an amendment has been submitted by the Tohono O'Odham Community Health
7 Department for review and approval.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
9 hereby approve the amendment to the Tohono O'Odham Psychological
10 Services and Alcoholism Program contracts.


12 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and Treasurer of the
13 Tohono O'Odham Nation are hereby authorized to negotiate and execute
14 this contract, and amendments thereto for the duration of this
15 contract, provided however, that any amendments affecting the
16 funding or funding levels of this contract shall be submitted for
17 futher prior approval by this Council.

19 The foregoing resolution was passed by the Tohono O'odham Council on the 3rd
20 day of August, 1987, at a meeting at which a quorum was present with a vote of
21 1523.0 for; -0- against; 117.0 not voting; and 07 absent, pursuant to the
22 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-
23 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
24 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
26 of June 18, 1934 (48 Stat. 984).


