## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (FY '88 Alcoholism Contract Proposal Amendment)

WHEREAS, the Tohono O'Odham Legislative Council did pass Resolution No's. 153 and 154-87 to authorize and request the Public Health, Indian Health Service to contract with the Tohono O'Odham Nation under P. L. 93-638 regulations and procedures for provisions of services titled:

Psychological Services and Alcoholism Program; and

WHEREAS, an amendment has been submitted by the Tohono O'Odham Community Health

Department for review and approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the amendment to the Tohono O'Odham Psychological Services and Alcoholism Program contracts.

BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and Treasurer of the Tohono O'Odham Nation are hereby authorized to negotiate and execute this contract, and amendments thereto for the duration of this contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 3rd day of August, 1987, at a meeting at which a quorum was present with a vote of 1523.0 for; -0- against; 117.0 not voting; and 07 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
