


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Domestic Affairs Committee Review of the General Counsel's Contract
with Strickland & Altaffer)

RES. NO. 263-87

1 WHEREAS, the Legislative Council on August 4, 1987, discussed the General
2 Counsel Contract between the Tohono O'odham Nation and the law firm of
3 Strickland & Altaffer, and
4
5 WHEREAS, the Domestic Affairs Committee informed the Council that they had not
6 met with the attorney to review the contract, and
7
8 WHEREAS, the Legislative Council deems it necessary that the Domestic Affairs
9 Committee meet with the attorney to review the General Counsel
10 Contract and bring back their recommendation to the Council.
11
12 NOW, THEREFORE, BE IT RESOLVED that the General Counsel Contract be referred
13 back to the Domestic Affairs Committee for a review with the attorney
14 and to submit their recommendation to the Council.

16 BE IT FURTHER RESOLVED that the time the attorney spends with the Committee for
17 Contract review not be charged to the Nation as attorney's fees.


18 The foregoing resolution was passed by the Tohono O'odham Council on the 4th
19 day of August, 1987, at a meeting at which a quorum was present with a vote of
20 1,153.5 for; 422.5 against; 64.0 not voting; and 01 absent, pursuant to the
21 powers vested in the Council by Section 1 (a) of Article VI of the Constitu-
22 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
23 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
25 of June 18, 1934 (48 Stat. 984).


