1	WHEREAS,	the Papago Council did on October 27, 1961, by Resolution No. 1192,
2		approve the granting of a lease of 12.23 acres of land within the
3		Agency reserve to the Indian Oasis School District No. 40, to be used
4		for Sells Consolidated School, living quarters and pertinent
5		installations, for a term of twenty-five years, starting January 1,
6		1962, with an option to renew for an additional twenty-five years; and
7	WHEREAS,	icle 2 of the lease provides that the "lease may be renewed at the
8		option of the Lessee for a further term of not to exceed twenty-five
0		(25) years, commencing at the expiration of the original term,
1		provided that notice of exercise of such option shall be given by the
2		Lessee to Lessor in writing at least twelve (12) months prior to said
3		expiration of original term"; and

WHEREAS, the original term of the lease expired on December 31, 1986, and the School District had inadvertently failed to exercise its renewal option; and

WHEREAS, the school district board did by the attached resolution request a waiver of the renewal option notice requirement and requested a renewal of the lease for a term of twenty-five years effective retroactively from January 1, 1987 through December 31, 2012; and

WHEREAS, the Natural Resources Committee has reviewed the request and has recommended that the request be honored.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that the Tohono O'Odham Nation does hereby waive the twelve (12) month renewal option notice requirement contained in article 2 of the Lease dated January 8, 1962, BIA Contract No. 14-20-0450-3918, Lease No. 454-15-62, and pursuant to the request contained in the attached resolution of the school district board, does hereby formally acknowledge renewal thereof, upon the same terms and conditions as in effect at the expiration of the original term, effective from the date of expiration
