

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending PTUA Plan of Operation)

RES. NO. 266-87

1 WHEREAS, the Papago Tribal Utility Authority ("PTUA") was created by Resolution
2 No. 8-70, which adopted a Plan of Operation setting forth its
3 purposes, authority and management; and

4 WHEREAS, the Council did, by Resolution No. 26-77, amend Section 20 of the Plan
5 of Operation and established a fiscal year for PTUA from January 1 to
6 December 30; and

7 WHEREAS, PTUA is the current subrecipient of a CDBG grant from the Department
8 of Housing and Urban Development and is consequently required to
9 conform to the requirements of the Single Audit Act of 1984, 31,
10 U.S.C. 7501 et seq. and 7 C.F.R. Part 3015, Audit of State and Local
11 Governments (O.M.B. Circular A-128), including the establishment of
12 a fiscal year starting October 1 and ending September 30; and



14 WHEREAS, PTUA has requested an amendment of Section 20 of its Plan of Operation
15 in order to change the fiscal year accordingly.

16 NOW, THEREFORE, BE IT RESOLVED that the Plan of Operation of the Papago Tribal
17 Utility is hereby amended by deleting the last phrase of Section 20
18 and substituting therefor the following: "The fiscal year of the
19 Authority shall be from October 1 to September 30,"

21 BE IT FURTHER RESOLVED that the foregoing amendment shall be effective
22 immediately and that PTUA's current fiscal year shall end on
23 September 30, 1987.

24 The foregoing resolution was passed by the Tohono O'odham Council on the 4th
25 day of August, 1987, at a meeting at which a quorum was present with a vote of
26 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers
27 vested in the Council by Section 1 (b) of Article VI of the Constitution of
28 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
