


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Pisinemo District Budget FY '88)

RES. NO. 268-87


1 WHEREAS, the District Council of the Pisinemo District did on July 11, 1987 by
2 Resolution No. 8-87, approved the attached FY 1988 District Budget in
3 the amount of \$101,159.37; and
4 WHEREAS, the Pisinemo District has sufficient funds in its I.I.M. Account to
5 cover the budget; and
6 WHEREAS, the Tohono O'Odham Council has reviewed the attached budget and
7 approves of same.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that it does
10 hereby approve the attached FY 1988 budget in the amount of
11 \$101,159.37 of the Pisinemo District and authorize expenditures in
12 accordance therewith.

13 The foregoing resolution was passed by the Tohono O'odham Council on the 4th
14 day of August, 1987, at a meeting at which a quorum was present with a vote of
15 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers
16 vested in the Council by Section 1 (d) of Article VI of the Constitution of the
17 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
18 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
19 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
20 1934 (48 Stat. 984).




