

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Two Members of the Human Resources Development Committee
to Attend the "Indian Education 1987" Course)

RES. NO. 273-87

1 WHEREAS, the Human Resource Development Committee of the Legislature is
2 currently addressing serious concerns regarding the operations of the
3 BIA school system on Tohono O'odham; and

4 WHEREAS, major initiatives affecting Native American Education are currently
5 being considered by Congress, which if enacted into Law, will greatly
6 affect the manner in which the Tohono O'odham Nation will provide
7 Education to its members; and


8 WHEREAS, it is essential that the Committee be fully informed of these
9 initiatives in order to adequately provide the Legislative Council
10 with recommendations to appropriately respond to these initiatives.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that
12 the Human Resources Development Committee is hereby authorized to
13 select two members to attend the "Indian Education 1987" session to
14 be held in Reno, Nevada on August 18-20, 1987.

15 BE IT FURTHER RESOLVED that the expenses identified are hereby authorized to
16 be paid from the Training Account of the Legislative Council's
17 budget.

21 The foregoing resolution was passed by the Tohono O'odham Council on the 5th
22 day of August, 1987, at a meeting at which a quorum was present with a vote of
23 1,228.5 for; 169.0 against; 242.5 not voting; and -0- absent, pursuant to the
24 powers vested in the Council by Section 1 (c)(2) & (d)(2) of Article VI of the
25 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham
26 Nation on January 18, 1986, and approved by the Acting Deputy Assistant
27 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
28 16 of the Act of June 18, 1934 (48 Stat. 984).
