1 WHEREAS, the Tohono O'odham Nation is a member in good standing with the
2 National Congress of American Indians, and
3 WHEREAS, per Resolution No. 437-86 the Legislative Chairperson Harriet Toro is
4 the Delegate to NCAI, and
5 WHEREAS, the Legislative Council Chairperson recommends that additional
6 members of the Tohono O'odham Legislative Council be appointed to
7 assist in gathering information on major issues effecting the Native
8 American Indians, as well as presenting concerns effecting the
9 Tohono O'odham Nation and seeking support from NCAI, and
10 WHEREAS, the necessary expenses will be paid out of the Tohono O'odham
11 Legislative Council's Budget, and
12 WHEREAS, by Legislative Order No. 271-87, authorized six (6) members to go to
13 NCAI, and
14 WHEREAS, by Legislative Order No. 272-87 the Tohono O'odham Legislative
15 Council did nominate and vote on the members to be appointed.

18 hereby certifies the following six (6) members as the Delegation to

Legislative Council on their return.


