

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tribal Action Plan)

RES. NO. 278-87

1 WHEREAS, the Tohono O'odham Nation has declared a war on alcoholism, and  
2 WHEREAS, the Tohono O'odham Nation has established a Tribal Coordinating  
3 Committee to develop a comprehensive plan for implementing the war on  
4 alcoholism, and

5 WHEREAS, it is in the best interests of the Tohono O'odham Nation,  
6 particularly the youth, that all tribal and federal agencies  
7 participate in this war on alcoholism, and



9 WHEREAS, the Tribal Coordinating Committee has developed a comprehensive plan  
10 which will establish a coordinated effort among the tribal and  
11 federal agencies, program and personnel in fighting this war on  
12 alcoholism.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has  
14 reviewed and approves the comprehensive plan for the war on  
15 alcoholism.

16 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council reserves  
17 the right to amend or modify this plan based on additional  
18 information as it becomes available.

20 The foregoing resolution was passed by the Tohono O'odham Council on the 5th  
21 day of August, 1987, at a meeting at which a quorum was present with a vote of  
22 1,359.5 for; 121.5 against; 159.0 not voting; and -0- absent, pursuant to the  
23 powers vested in the Council by Section 1 (c)(2) of Article VI of the Consti-  
24 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the  
Act of June 18, 1934 (48 Stat. 984).
