


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Case Regarding the Children of Cecilia Hernandez to be Tabled)


1 WHEREAS, the Enrollment Committee scheduled a rejection hearing on August 6,
2 1987, for the children of Cecilia Hernandez (Galvez), and
3 WHEREAS, the Enrollment Committee recommended the rejection of the children of
4 Cecilia Hernandez (Galvez) for not meeting the requirements of Article
5 II - Membership Section 1(b),
6 "All children born to resident members," and
7 WHEREAS, Cecilia Hernandez (Galvez) presented documents at the hearing which
8 the Legislative Council feels needs further review.

10 NOW, THEREFORE, BE IT RESOLVED that the case involving Cecilia Hernandez'
11 (Galvez') children is tabled and referred to the Enrollment Committee
12 to follow up on documents presented to the Tohono O'odham Legislative
13 Council.

15 The foregoing resolution was defeated by the Tohono O'odham Council on the 6th
16 day of August, 1987, at a meeting at which a quorum was present with a vote of
17 510.0 for; 922.5 against; 207.5 not voting; and -0- absent, pursuant to the
18 powers vested in the Council by Section 1 (h) of Article VI of the Constitu-
19 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
20 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
22 of June 18, 1934 (48 Stat. 984).



5 either approve or disapprove it within 48 hours of submittal.


