
11 WHEREAS, the Council did hear testimony of the family involved and were not

15 the membership applications of:



25 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
26 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
28 of June 18, 1934 (48 Stat. 984).


