RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Denying Recommendation of Enrollment Committee Regarding the Children of Maria Rufina Leon; Returning it to the Enrollment Committee along with the Case Regarding the Children of Cecilia Hernandez)

RES. NO. 281-87

WHEREAS, the Enrollment Committee scheduled a rejection hearing on August 6, 1987, for Maria Rufina Leon's children, who applied for membership 3 with the Tohono O'odham Nation, and

WHEREAS, the Enrollment Committee recommended the rejection of Maria Rufina Leon's children for not meeting the requirements of Article II -Membership, Section 2.

> "The Council shall have the power to adopt into membership anyone who is one-half (1/2) degree or more of Papago -Tohono O'odham Indian blood." and

WHEREAS, the hearing produced more information that requires further research by the Enrollment Committee.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the recommendation of the Enrollment Committee to reject Maria Rufina Leon's children for membership is denied and referred back to the Enrollment Committee for further review.

BE IT FURTHER RESOLVED by the Legislative Council that applications for membership of Cecilia Hernandez' children be also referred back to the Enrollment Committee.

The foregoing resolution was passed by the Tohono O'odham Council on the 6th day of August, 1987, at a meeting at which a quorum was present with a vote of 1,511.5 for; -O- against; 128.5 not voting; and -O- absent, pursuant to the powers vested in the Council by Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
