

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Adoption into the Tohono O'odham Nation)

RES. NO. 283-87

1 WHEREAS, BERNAL, SONYA M.; has made application for adoption in the  
2 Tohono O'odham Nation pursuant to Section 2 of Article II of the  
3 Constitution of the Tohono O'odham Nation; and

5 WHEREAS, the Enrollment Committee has reviewed her application, has made a final  
6 determination that she is 1/2 degree or more of Papago-Tohono O'odham  
7 Indian blood, and have made a recommendation to the Tohono O'odham  
8 Council that her application be approved, all in accordance with the  
9 provisions of the Enrollment Ordinance; and

10 WHEREAS, the Tohono O'odham Council has reviewed the recommendation of the En-  
11 rollment Committee and the evidence submitted in support of the  
12 individual application.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that the appli-  
15 cation for adoption filed by:

16 103-ND-87 BERNAL, Sonya


17 is hereby approved and that she is hereby adopted into membership of

19 The foregoing resolution was passed by the Tohono O'odham Council on the 6th day  
20 of August, 1987, at a meeting at which a quorum was present with a vote of  
21 1,344.5 for; 120.5 against; 175.0 not voting; and 05 absent, pursuant to the  
22 powers vested in the Council by Section 2 of Article II and Article VI Section  
23 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
24 O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant  
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
26 of the Act of June 18, 1934 (48 Stat. 984).


