


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Readvertising the Full-time Judge's Position)

RES. NO. 284-87 DEFEAT


1 WHEREAS, the Tohono O'odham Legislative Council did meet today to consider the
2 appointment of a full-time judge, and
3 WHEREAS, the Judicial Committee did conduct preliminary interviews with the two
4 individuals who applied, and
5 WHEREAS, the Judicial Committee did not make any recommendation as to who the
6 committee supports but gave individual statements as to what should be
7 considered in the appointed candidate.

9 NOW, THEREFORE, BE IT RESOLVED that after interviewing the two applicants, the
10 Tohono O'odham Legislative Council hereby directs that the full-time
11 judge's position be readvertised.

12 The foregoing resolution was defeated by the Tohono O'odham Council on the 7th
13 day of August, 1987, at a meeting at which a quorum was present with a vote of
14 708.5 for; 931.5 against; -0- not voting; and 02 absent, pursuant to the powers
15 vested in the Council by Section 1(a)(b) of Article VI and Section 4 Article
16 VIII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
17 O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
19 16 of the Act of June 18, 1934 (48 Stat. 984).

5 either approve or disapprove it within 48 hours of submittal.


