

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to negotiate & execute P. L. 93-638 Recontracts)

1 WHEREAS, the Tohono O'Odham Legislative Council did authorize and request the
2 Bureau of Indian Affairs to contract with the Tohono O'Odham Nation
3 under P. L. 93-638 regulations and procedures for the following FY '88
4 recontracts:

- 6 2. Human Services - Resolution No. 144-87
- 7 3. Children's Home - Resolution No. 145-87
- 8 4. Adult Group Home Care - Resolution No. 146-87
- 9 5. Agriculture Extension - Resolution No. 147-87
- 10 6. Johnson O'Malley - Resolution No. 148-87
- 11 7. Employment Assistance - Resolution No. 149-87
- 12 8. Higher Education - Resolution No. 150-87
- 13 9. Law Enforcement - Resolution No. 127-87


14 WHEREAS, Josiah Moore, Chairman; Francisco Jose, Jr., Vice Chairman and Rosita
15 Ruiz, Treasurer of the Tohono O'Odham Nation were authorized to
16 negotiate and execute these contracts; and

17 WHEREAS, the Tohono O'Odham Nation did have an election and the above people
18 are no longer in office.

19 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
20 the Chairman, Vice-Chairman and Treasurer of the Tohono O'Odham Nation
21 are hereby authorized to negotiate and execute these contracts and any
22 amendments thereto for the duration of these contracts, provided
23 however, that any amendments affecting the funding or funding levels
24 of these contracts shall be submitted for further prior approval by
25 this Council.

26 The foregoing resolution was passed by the Tohono O'odham Council on the 8th
27 day of September, 1987, at a meeting at which a quorum was present with a vote
28 of 1523.0 for; -0- against; 117.0 not voting; and -0- absent, pursuant to the
29 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-
30 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
31 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
32 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
