


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Sells District Budget FY-1988)


1 WHEREAS, the Legislative Council of the Tohono O'odham Nation have received,  
2 and examined the budget of the Sells District; and  
3 WHEREAS, the Sells District has adopted Resolution Number 12-87 as their legal  
4 passage to spend for their operation expenses for fiscal year 1988 in  
5 the amount of \$150,654.00; and  
6 WHEREAS, Sells District has sufficient funds in the IIM Account to cover their  
7 projected expenses.  
8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that  
9 it does hereby approve the Sells District Budget in the amount of  
10 \$150,654.00.

12 The foregoing resolution was passed by the Tohono O'odham Council on the 8th  
13 day of September, 1987, at a meeting at which a quorum was present with a vote  
14 of 1,640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the  
15 powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitu-  
16 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
17 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
19 of June 18, 1934 (48 Stat. 984).
