3 cipated cost and expenses for FY 87-88; and


4 WHEREAS, the Gu Achi District Council did adopt and approve the proposed budget

7 budget and approves of same.


8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that

14 of 1,640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the
15 powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitu-
16 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
