2 Budget for FY 1988 for the Hickiwan District; and


3 WHEREAS, the Hickiwan District has sufficient funds to cover such budget; and

5 approved of same.


6 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that
7 it does hereby approve the attached FY '88 budget of the Hickiwan
8 District and does hereby authorize expenditures from the Districts
9 accounts in accordance therewith.

11 The foregoing resolution was passed by the Tohono O'odham Council on the 8th
12 day of September, 1987, at a meeting at which a quorum was present with a vote
13 of 1,581.5 for; -0- against; 58.5 not voting; and -0- absent, pursuant to the
14 powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitu-
15 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
16 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
18 of June 18, 1934 (48 Stat. 984).




