1	WHEREAS, the Bureau of Indian Affairs budget line item entitled Aid to Tribal
2	Government Services has unspent funds in the amount of \$47,000; and
3	WHEREAS, these funds can be used to supplement an existing contracted program
4	subject to review and approval by the Tohono O'odham Legislative
5 6	Council; and
7	WHEREAS, the Justice Program (Advocate) is currently operating under a self-
8	determination grant which will be depleted and is nonrenewable; and
9	WHEREAS, the services provided by the Justice Program through its advocate and
10	legal representation is vital and depended on by members of the nation
11	who require legal services; and
12	WHEREAS, the Tohono O'odham Judiciary is operating under a contract and is
13	willing to amend its contract to incorporate the unspent funds of
14	\$47,000 for use by the Advocate Program; and

16	WHEREAS, the Legislative Council can approve any amendments affecting funding
17	or funding levels after proper review.
18	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that
19	the Chairman, Vice Chairman and Treasurer of the Tohono O'odham Nation
20 21	are hereby authorized to negotiate and execute these contracts and any
21	amendments thereto for the duration of this contract, provided
23	however, that any amendments affecting the funding or funding levels
24	of this contract shall be submitted for further prior approval by this
25	Council.
26	The foregoing resolution was passed by the Tohono O'odham Council on the <u>8th</u>
27	day of September, 1987, at a meeting at which a quorum was present with a vote of $1,581.5$ for; -0- against; $58.5$ not voting; and -0- absent, pursuant to the
28	powers vested in the Council by Section 1 (f) of Article VI of the Constitu- tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
29	January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
30	of June 18, 1934 (48 Stat. 984).
