

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Water Resources Contract Amendment)

RES. NO. 296-87

1 WHEREAS, Section 303 (B) (1) of Title II of P. L. 97-293, the Southern Arizona
2 Water Rights Settlement Act of 1982 authorized and directed that a
3 study be done to determine the availability and suitability of Water
4 Resources within the Tohono O'Odham Nation; and

5 WHEREAS, the Tohono O'Odham Nation has entered into a multi-year contract with
6 the Bureau of Indian Affairs; and

7 WHEREAS, the Tohono O'Odham Legislative Council did pass Resolution No. 126-87
8 approving an amendment to the Water Resources Study Contract in the
9 amount of \$1,100,000.00; and

10 WHEREAS, an additional \$240,000.00 has been allocated for the study of Water
11 Resources within the Tohono O'Odham Nation; and

12 WHEREAS, any amendments affecting the funding or funding levels of the contract
13 shall be submitted for review and approval by the Tohono O'Odham
14 Legislative Council; and

15 WHEREAS, an amendment has been submitted by the Tohono O'Odham Nation Water
16 Resource Program for review and approval.

17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
18 hereby approve this amendment to the Water Resources Study Contract in
19 the amount of \$240,000.00

20 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the
21 Chairman, Vice-Chairman and Treasurer of the Tohono O'Odham Nation are
22 hereby authorized to negotiate and execute this contract and any
23 amendments affecting the funding or funding levels of this contract
24 shall be submitted for further prior approval by this Council.

25 The foregoing resolution was passed by the Tohono O'odham Council on the 8th
26 day of September, 1987, at a meeting at which a quorum was present with a vote
27 of 1282.0 for; 241.0 against; 117.0 not voting; and -0- absent, pursuant to the
28 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-
29 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
30 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
31 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
32 of June 18, 1934 (48 Stat. 984).
