

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Earn Demonstration Project)

RES. NO. 298-87

1 WHEREAS, the Department of the Interior has indicated that funds are available  
2 for the purpose of funding self-assistance programs under the EARN  
3 Demonstration Project Announcement; and

4 WHEREAS, the Tohono O'Odham Nation recognizes the need for a program which will  
5 foster economic independence and self sufficiency in individuals and  
6 families; and

7 WHEREAS, the Tohono O'Odham has successfully operated the Tribal Work  
8 Experience Program and other work-training programs; and

9 WHEREAS, the Tohono O'Odham Legislative Council does desire to contract for an  
10 EARN Demonstration Project which would supplement the current Tribal  
11 Work Experience Program (TWEP) not replace it; and

12 WHEREAS, the Tohono O'Odham Council has reviewed and approved the proposed  
13 contract for the EARN Demonstration Project; and

14 WHEREAS, the Tohono O'Odham Nation is eligible to apply for funding for an EARN  
15 Demonstration Project.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that it does  
17 hereby approve the application of the Tohono O'Odham Service  
18 Department for a three year EARN Demonstration Project funds to  
19 develop and implement Workfare Demonstration Project.

20 BE IT FURTHER RESOLVED that the term of this contract shall commence on October  
21 01, 1987 and end on September 30, 1990.

22 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the  
23 Chairman, Vice-Chairman and Treasurer of the Tohono O'Odham Nation are  
24 hereby authorized to negotiate and execute this contract and any  
25 amendments thereto for the duration of this contract, provided  
26 however, that any amendments affecting the funding or funding levels of  
27 this contract shall be submitted for further prior approval by this  
28 Council.

1 The foregoing resolution was passed by the Tohono O'odham Council on the 8th  
2 day of September, 1987, at a meeting at which a quorum was present with a vote  
3 of 1286.5 for; 236.5 against; 117.0 not voting; and -0- absent, pursuant to the  
4 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-  
5 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
6 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
7 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
8 of June 18, 1934 (48 Stat. 984).
