

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Referring Capital Improvement/Economic Development for Committee Review)
RES. NO. 309-87

1 WHEREAS, the Legislative Council Agenda for September 10, 1987 included the
2 Commerce Committee's recommendation to set aside 20% of the Land
3 Judgment Fund as authorized for the benefit of the Tohono O'odham
4 Nation's members; and

5 WHEREAS, the Legislative Council questioned whether the proposed 20% set aside
6 fund presented had proper committee review as stipulated in the Legis-
7 lative Rules; and

8 WHEREAS, the Legislative Council recognizes the importance of the Commerce
9 Committee's recommendation, because it would benefit members of the
10 Tohono O'odham Nation.

11 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the proposed
12 recommendation of the 20% set aside funds from the Land Judgment be
13 referred back to the Commerce and Budget & Finance Committees for
14 further review and discussion.


15 The foregoing resolution was passed by the Tohono O'odham Council on the 10th
16 day of September, 1987, at a meeting at which a quorum was present with a vote
17 of 1,555.5 for; -0- against; 84.5 not voting; and -0- absent, pursuant to the
18 powers vested in the Council by Section 1 (a) of Article VI of the Constitu-
19 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
20 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
22 of June 18, 1934 (48 Stat. 984).
