RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Referring Capital Improvement/Economic Development for Committee Review)

RES. NO. 309-87

WHEREAS, the Legislative Council Agenda for September 10, 1987 included the Commerce Committee's recommendation to set aside 20% of the Land Judgment Fund as authorized for the benefit of the Tohono O'odham Nation's members; and

WHEREAS, the Legislative Council questioned whether the proposed 20% set aside fund presented had proper committee review as stipulated in the Legislative Rules; and

WHEREAS, the Legislative Council recognizes the importance of the Commerce Committee's recommendation, because it would benefit members of the Tohono O'odham Nation.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the proposed recommendation of the 20% set aside funds from the Land Judgment be referred back to the Commerce and Budget & Finance Committees for further review and discussion.

The foregoing resolution was passed by the Tohono O'odham Council on the 10th day of September, 1987, at a meeting at which a quorum was present with a vote of 1,555.5 for; -0- against; 84.5 not voting; and -0- absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
