

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting Resolution No. 7-87 of the Pisinemo District)

RES. NO. 310-87

1 WHEREAS, the Pisinemo District Council did meet on May 16, 1987, to review and
2 address, Indian Health Services (IHS) request to construct a fence
3 inside Pisinemo District, and

4 WHEREAS, the proposed fence will enclose an accessible road, leading to their
5 two-way radio relay station, located on top of Quijotoa Mountain Range
6 in the Gu Achi District; and

7 WHEREAS, the fence would serve to prevent livestock from wandering in and out
8 of Pisinemo/Gu Achi Districts; and


9 WHEREAS, the Pisinemo District Council, is supportive of the fence, for the
10 purposes stated above, but with conditions that the original fence
11 posts be left in place and documented, to signify the original fence
12 lines between the two Districts of Gu Achi and Pisinemo.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council,
15 supports Pisinemo District's Resolution "Permit for Indian Health
16 Services (IHS) to construct a Fence, #7-87."

17 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council, that IHS be
18 held responsible, in reconnecting the original fence at such time when
19 the relay station is no longer in use or is shut down.

21 The foregoing resolution was passed by the Tohono O'odham Council on the 10th
22 day of September, 1987, at a meeting at which a quorum was present with a vote
23 of 1,523.0 for; 58.5 against; 58.5 not voting; and -0- absent, pursuant to the
24 powers vested in the Council by Section 1 (i)(2) of Article VI of the Constitu-
25 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
