WHEREAS, the Tohono O'odham Nation has retained the law firm of Strickland and Altaffer, P.C. under a General Counsel Contract dated September 12, 1985, (Symbol H50C1420-Contract No. 5360); and WHEREAS, said General Counsel Contract expires on the 24th day of September, 1987, and the law firm of Strickland and Altaffer, P.C. has performed its duties under said contract proficiently and competently; and WHEREAS, it is the desire of the Nation to retain the law firm of Strickland and Altaffer, P.C. as general counsel for an additional one-year period. NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the law firm of

Strickland and Altaffer, P.C. be employed by the Tohono O'odham Nation under and pursuant to the terms of the attached General Counsel Contract, and any amendments or extension thereof, and the Chairman of the Tohono O'odham Nation is hereby authorized and directed to execute said Contract for and behalf of the Nation.

The foregoing resolution was passed by the Tohono O'odham Council on the $\underline{11th}$ day of September, 1987, at a meeting at which a quorum was present with a vote of $\underline{1,000.5}$ for; $\underline{587.0}$ against; $\underline{52.5}$ not voting; and $\underline{-0-}$ absent, pursuant to the powers vested in the Council by Section 2 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
