

RESOLUTION OF THE TOHONO O'ODHAM COUNCIL
(General Counsel Contract 1987-1988)

RES. NO. 313-87

1 WHEREAS, the Tohono O'odham Nation has retained the law firm of Strickland and
2 Altaffer, P.C. under a General Counsel Contract dated September 12,
3 1985, (Symbol H50C1420-Contract No. 5360); and
4 WHEREAS, said General Counsel Contract expires on the 24th day of September,
5 1987, and the law firm of Strickland and Altaffer, P.C. has performed
6 its duties under said contract proficiently and competently; and
7 WHEREAS, it is the desire of the Nation to retain the law firm of Strickland
8 and Altaffer, P.C. as general counsel for an additional one-year
9 period.

11 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the law firm of
12 Strickland and Altaffer, P.C. be employed by the Tohono O'odham Nation
13 under and pursuant to the terms of the attached General Counsel
14 Contract, and any amendments or extension thereof, and the Chairman of
15 the Tohono O'odham Nation is hereby authorized and directed to execute
16 said Contract for and behalf of the Nation.

18 The foregoing resolution was passed by the Tohono O'odham Council on the 11th
19 day of September, 1987, at a meeting at which a quorum was present with a vote
20 of 1,000.5 for; 587.0 against; 52.5 not voting; and -0- absent, pursuant to the
21 powers vested in the Council by Section 2 (a) of Article VI of the Constitu-
22 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
23 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
25 of June 18, 1934 (48 Stat. 984).



5 either approve or disapprove it within 48 hours of submittal.


