

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(IHS Contract to Provide Rehabilitation and Aftercare Services as  
Required by the Omnibus Drug Act, P.L. 99-507)

RES. NO. 316-87

1 WHEREAS, under P.L. 93-638, the Indian Self-Determination Act, the Tohono  
2 O'odham Nation has the authority to contract with Indian Health  
3 Service (IHS) to provide certain services, and  
4

5 WHEREAS, the Omnibus Drug Act, P.L. 99-570, requires that rehabilitation and  
6 aftercare services be provided to the youth of the Tohono O'odham  
7 nation, and

8 WHEREAS, the Tohono O'odham Nation desires to contract with IHS to provide  
9 rehabilitation and aftercare services to the Tohono O'odham youth.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has  
11 reviewed and approved the proposed contract to provide the  
12 rehabilitation and aftercare services to the Tohono O'odham youth as  
13 required by P.L. 99-570.

15 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the  
16 Chairman, Vice Chairman or Treasurer of the Tohono O'odham Nation are  
17 hereby authorized to negotiate and execute the contract and any  
18 amendments thereto for the duration of the contract, provided however,  
19 that any amendments affecting the funding or funding levels of the  
20 contract shall be submitted for further prior approval by this  
21 Council.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 11th  
24 day of September, 1987, at a meeting at which a quorum was present with a vote  
25 of 1,407.5 for; 85.0 against; 147.5 not voting; and 01 absent, pursuant to the  
26 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-  
27 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984).
